# Methodology

Atomic awards data is categorized, and naming conventions standardized. This highlights which firms, lawyers, cases and deals are receiving the greatest recognition via a nomination/win ratio. Awards data from the following sources are used in our research:

Asian Legal Business, ALM, asialaw, Benchmark Litigation, China Business Law Journal, Chambers and Partners, China Law and Practice, India Business Law Journal, International Financial Law Review, In-house Community, Legal 500, Managing IP.

The awards period used for our research is January to December 2022.

Legal Media 360's awards analysis splits firm awards into two distinct categories: Firm awards and Case/deal awards.



# **Award Categories**

#### **Firm Awards**

Firm awards include categories such as practice area specific awards, practice management, diversity and inclusion and firm-wide awards (such as firm of the year).

The following data is for Taiwan (domestic firms).

Commentary: In 2022, a total of 11 firms were nominated for firm related awards. Only three firms won awards. Lee and Li and Tsar & Tsai had the most firm award nominations and both won the same number of awards.



# Case/Deal Awards

Case/deal awards recognise the firms working on the most significant matters in the past 12 months.

**Commentary:** Three of the five firms nominated for case/deal awards won. Lee and Li was nominated the greatest number of times, however LCS & Partners and Tsar & Tsai had a better nomination to win conversion ratio.



# **Lawyer Awards**

In the 12 publications examined, only one publication (Benchmark Litigation) had lawyer awards for Taiwan.

In Benchmark Litigation a total of six lawyers in Taiwan were nominated (three male and three female lawyers).
